This is a meaningful opportunity to contribute to real change and to join a forward-thinking, inclusive Board that supports a committed leadership team delivering vital frontline services.



We support people who may be homeless, vulnerable, or socially isolated.



What are we looking for in our next Trustee?

What is the role of the Board of Trustees?

Trustees act as both ambassadors and guardians of the Trust, ensuring we remain true to our values while steering the Trust towards sustainable growth and deeper community impact.

You'll contribute to strategic decisions, oversee financial and legal responsibilities, and provide oversight to ensure the charity delivers meaningful outcomes across Suffolk and Norfolk.

This is an opportunity to use your skills and lived experience to make a tangible difference in the lives of vulnerable people.

What skills are we looking for?

We are keen to hear from individuals who have experience in:

- Accountancy and Finance
- Legal
- Housing and Social Care
- Marketing
- Governance and Leadership
- People Management and Development
- Operational Management
- Marketing
- Fundraising
- Health and Care Sector

What's the commitment required?

Typically, two to three meetings (board, committee, or development day) per quarter with a commitment equivalent of one to two days per month in total. Meetings are usually held in person at one of our sites in Lowestoft, Suffolk.

How do I know if I am eligible to become a Trustee?

To be considered as a Trustee you must:

- Be at least 16 years old to be a charity trustee.
- Some people are disqualified by law from acting as charity trustees. (Subject to waiver provisions, this includes anyone who:)
 - Has an unspent conviction for an offence involving dishonesty or deception.
 - Is currently declared bankrupt (or is subject to bankruptcy restrictions or an interim order) or has an individual voluntary agreement (IVA) with creditors.
 - Is disqualified from being a company director.
 - Has previously been removed as a trustee by either the commission or the High Court due to misconduct or mismanagement.

All new Trustees will be required to sign a declaration of eligibility and agree to additional background checks, such as a disclosure and barring service (DBS) check.

Is there remuneration?

This post is not remunerated but reasonable expenses for travel will be paid.

The next steps in becoming a Trustee at Access Community Trust will be:

- Make a formal application, please send us your CV, along with a covering statement outlining your interest and highlighting your relevant experience to Samantha Shevlin, Chair of Scrutiny and Governance at samantha.shevlin@accessct.org.
- You will then be invited to meet with the Emma Ratzer (CEO), Bradley Adnams (Chair of the Board) and Samantha Shevlin (Chair of the Governance and Scrutiny Committee) to get an overview of our Trustee role, overview of our charity and work, and discuss the specific skills and experience you can bring to the board.
- You will then be asked to confirm your eligibility to serve as a Trustee and your interest in doing so in writing, along with a supporting personal statement and CV outlining why you are interested in becoming a Trustee of Access Community Trust, and the skills and experience you would bring to the role.
- Potential trustees will be invited to attend a board meeting to introduce themselves and to discuss their application.
